IS JULY 14.

A CERTIFICATE OF LIABILITY INSURANCE is a free service provided by most insurance companies. Call your company before July 14, give them the dates of the Farm Show, and they will fax us (724-482-9118) a certificate showing that you have current liability insurance.

1. A separate entry form must be used for each species and each exhibitor. DO NOT list more than one department (species) on any entry.
2. Breed must be written on entry form.
3. Write total number of animals entered on form.
4. Junior exhibitors who show their animals in both the junior classes and OPEN SHOW must pay the entry fees for the open show.
5. Exhibitors must have a Butler Farm Show Exhibitor's number. Call the office in July if you need your number or a new number before submitting your entry form on July 14. Your number starts with the initial of your last name. This number is to be used on your entries in ANY and ALL departments of the show.
6. Anyone removing their exhibits before the designated times will forfeit their premiums.
7. Exhibitors will comply with all directions given by a Director, Farm Show Official, or any police or security officer. Failure to immediately comply with the directions will be cause for the exhibitor to be disqualified and be prohibited from entering any future Butler Farm Show exhibitions or showings.
8. The Exhibitor agrees to and shall assume all risks of bodily injury to animals or damage to property.
9. The Exhibitor agrees that the Butler Farm Show will not be liable nor responsible for any injury or death to any person nor damage to any property from any cause whatsoever, and the Exhibitor will indemnify the Butler Farm Show for all costs, expenses, fees, verdicts, judgements expert and attorney fees arising from or as a result of any claim, demand, legal actions, or liability pertaining to the use or occupancy of said property and buildings.
