1. Exhibitors are limited to 15 entries per exhibitor, including doe & litter, single fryer, and meat pens. Exhibitors are limited to 1 doe & litter entry, 1 single fryer entry and 2 meat pens.

3. Breed and/or variety must be shown on entry.
4. NUMBER IN A DOE & LITTER ENTRY MUST BE WRITTEN ON ENTRY FOR COOPING PURPOSES.
5. **Junior exhibitors** showing their rabbits in BOTH the Open and Junior Shows must pay the entry fees for the open show (\$1./entry).
